PRECAUTIONS

RE-ENTRY PERIOD

Post-Construction and General Pest Control:

Allow reated areas to dry completely (normally 3-4 hours) and ventilate buildings before re-occupying. When prior entry is necessary, When prior entry is necessary, wear cotton overalls buttoned to the neck, wrist and elbow-length PVC, neoprene or nitrile gloves and chemical resistant footwear. Clothing must be laundered after each day's use.

Crops, Ornamentals, Turf – The operator should wear suitable protective clothing (ie water proof boots, overalls and gloves) when walking on or handling newly sprayed turf before the spray deposits have dried or been watered-in or before re-entering treated crops.
